In view of the documentation provided, and in accordance with the provisions of Article 100.2 of Royal Decree 1060/2015, of 20 November, on the regulation, supervision and solvency of insurance and reinsurance companies, I have decided as follows:

To order the opening of the public information period, authorising the interested entities to publish notices on their website, in one of the most widely circulated newspapers of the province in which they have their registered office, and in another national newspaper, making the planned transfer known and advising policy holders of their right to inform the Directorate-General for Insurance and Pension Funds, within one month following the final publication, of any objections they may have to the transfer.

The companies are reminded that, at the earliest possible opportunity, they must send this directorate evidence of having published the above notices, which must be made in general-information newspapers.

Furthermore, in accordance with the provisions of Article 22.1.a) of Act 39/2015, of 1 October, on the Common Administrative Procedure for Public Sector Bodies, the interested parties are informed that the time limit for concluding the transfer process is suspended until the period of one month granted to policyholders to express their disagreement with the transfer has finalised."
